1 AN ACT relating to the sale and consumption of alcoholic beverages;
2 amending K.S.A. 41-2706 and 41-2726 and K.S.A. 2016 Supp. 41-102,
3 41-307, 41-308, 41-2701, 41-2702, 41-2704, 41-2708 and 41-2722 and
4 repealing the existing sections; also repealing K.S.A. 41-103.

6 *Be it enacted by the Legislature of the State of Kansas:*

7 New Section 1. (a) Notwithstanding the provisions of K.S.A. 41-
8 1101, and amendments thereto, or the provisions of the Kansas cereal malt
9 beverage act, a distributor may establish reasonable minimum order
10 quantities or minimum dollar value of an order, or both, for alcoholic
11 liquor and cereal malt beverages distributed by the distributor to a retailer.

12 (b) The provisions of K.S.A. 41-1101(b), and amendments thereto,
13 shall apply to a person licensed pursuant to K.S.A. 41-2702, and
14 amendments thereto, to sell cereal malt beverage and beer containing not
15 more than 6% alcohol by volume to the same extent it applies to a retailer
16 licensed pursuant to the Kansas liquor control act, and the provisions of
17 K.S.A. 41-1101(d), and amendments thereto, shall apply to a retailer
18 licensed pursuant to the Kansas liquor control act to the same extent it
19 applies to a retailer licensed pursuant to K.S.A. 41-2702, and amendments
20 thereto.

21 (c) This section shall be a part of and supplemental to the Kansas
22 liquor control act.

23 (d) The provisions of this section shall be effective on and after April
24 1, 2019.

25 New Sec. 2. (a) It is hereby declared to be the intent of the legislature
26 that, for the purposes of any agreement entered into prior to April 1, 2019,
27 pursuant to K.S.A. 41-410, and amendments thereto, between a supplier
28 and a distributor regarding the geographic territory within which the
29 distributor may sell one or more brands of the supplier's cereal malt
30 beverage or beer, or both, the term "cereal malt beverage" shall have the
31 meaning ascribed to such term in K.S.A. 41-2701, and amendments
32 thereto, on the effective date of this act, and the term "beer" shall have the
33 meaning ascribed to such term in K.S.A. 41-102, and amendments thereto,
34 on the effective date of this act.

35 (b) This section shall be a part of and supplemental to the Kansas
36 liquor control act.

1 (c) The provisions of this section shall be effective on and after April
2 1, 2019.

3 New Sec. 3. (a) Following the 10th anniversary of the effective date of
4 this act, the director shall conduct a market impact study of the sale of beer
5 containing not more than 6% alcohol by volume by persons licensed as
6 cereal malt beverage retailers pursuant to K.S.A. 41-2702, and
7 amendments thereto. Such study shall include, but not be limited to, the
8 changes subsequent to the effective date of this act, if any, in the number
9 of retailers and the reasons for any changes; the changes subsequent to the
10 effective date of this act, if any, in the number of persons licensed to sell
11 cereal malt beverage in the original package for use or consumption off of
12 and away from the licensed premises, and the reasons for any changes; the
13 effect of this act on state and local tax revenues; the impact of this act on
14 employment; and such other factors as the director deems pertinent. A
15 report on the director's findings from such study shall be submitted to the
16 legislature prior to adjournment of the 2029 session of the legislature.

17 (b) The director shall have oversight over the sale of beer containing
18 not more than 6% alcohol by volume by persons licensed as cereal malt
19 beverage retailers pursuant to K.S.A. 41-2702, and amendments thereto, to
20 ensure that such sales promote an orderly market. For such purpose, the
21 director may adopt such rules and regulations as the director deems
22 necessary and appropriate, including rules and regulations making
23 applicable to cereal malt beverage retailers selling beer containing not
24 more than 6% alcohol by volume such provisions of the existing rules and
25 regulations concerning industry trade practices as are necessary and
26 appropriate. The rules and regulations authorized by this section shall be
27 promulgated by the director on or before July 1, 2018.

28 Sec. 4. On and after April 1, 2019, K.S.A. 2016 Supp. 41-102 is
29 hereby amended to read as follows: 41-102. As used in this act, unless the
30 context clearly requires otherwise:

31 (a) "Alcohol" means the product of distillation of any fermented
32 liquid, whether rectified or diluted, whatever its origin, and includes
33 synthetic ethyl alcohol but does not include denatured alcohol or wood
34 alcohol.

35 (b) "Alcoholic liquor" means alcohol, spirits, wine, beer and every
36 liquid or solid, patented or not, containing alcohol, spirits, wine or beer
37 and capable of being consumed as a beverage by a human being, but shall
38 not include any cereal malt beverage.

39 (c) "Beer" means a beverage, containing more than 3.2% alcohol by
40 weight, obtained by alcoholic fermentation of an infusion or concoction of
41 barley, or other grain, malt and hops in water and includes beer, ale, stout,
42 lager beer, porter and similar beverages having such alcoholic content.

43 (d) "Caterer" has the meaning provided by K.S.A. 41-2601, and

1 amendments thereto.

2 (e) "Cereal malt beverage" has the meaning provided by K.S.A. 41-
3 2701, and amendments thereto.

4 (f) "Club" has the meaning provided by K.S.A. 41-2601, and
5 amendments thereto.

6 (g) "Director" means the director of alcoholic beverage control of the
7 department of revenue.

8 (h) "Distributor" means the person importing or causing to be
9 imported into the state, or purchasing or causing to be purchased within
10 the state, alcoholic liquor for sale or resale to retailers licensed under this
11 act or cereal malt beverage for sale or resale to retailers licensed under
12 K.S.A. 41-2702, and amendments thereto.

13 (i) "Domestic beer" means beer which contains not more than 10%
14 alcohol by weight and which is manufactured in this state.

15 (j) "Domestic fortified wine" means wine which contains more than
16 14%, but not more than 20% alcohol by volume and which is
17 manufactured in this state.

18 (k) "Domestic table wine" means wine which contains not more than
19 14% alcohol by volume and which is manufactured without rectification or
20 fortification in this state.

21 (l) "Drinking establishment" has the meaning provided by K.S.A. 41-
22 2601, and amendments thereto.

23 (m) "Farm winery" means a winery licensed by the director to
24 manufacture, store and sell domestic table wine and domestic fortified
25 wine.

26 (n) "Hard cider" means any alcoholic beverage that:

27 (1) Contains less than 8.5% alcohol by volume;

28 (2) has a carbonation level that does not exceed 6.4 grams per liter;
29 and

30 (3) is obtained by the normal alcoholic fermentation of the juice of
31 sound, ripe apples or pears, including such beverages containing sugar
32 added for the purpose of correcting natural deficiencies.

33 (o) "Manufacture" means to distill, rectify, ferment, brew, make, mix,
34 concoct, process, blend, bottle or fill an original package with any
35 alcoholic liquor, beer or cereal malt beverage.

36 (p) (1) "Manufacturer" means every brewer, fermenter, distiller,
37 rectifier, wine maker, blender, processor, bottler or person who fills or
38 refills an original package and others engaged in brewing, fermenting,
39 distilling, rectifying or bottling alcoholic liquor, beer or cereal malt
40 beverage.

41 (2) "Manufacturer" does not include a microbrewery, microdistillery
42 or a farm winery.

43 (q) "Microbrewery" means a brewery licensed by the director to

1 manufacture, store and sell domestic beer and hard cider.

2 (r) "Microdistillery" means a facility which produces spirits from any
3 source or substance that is licensed by the director to manufacture, store
4 and sell spirits.

5 (s) "Minor" means any person under 21 years of age.

6 (t) "Nonbeverage user" means any manufacturer of any of the
7 products set forth and described in K.S.A. 41-501, and amendments
8 thereto, when the products contain alcohol or wine, and all laboratories
9 using alcohol for nonbeverage purposes.

10 (u) "Original package" means any bottle, flask, jug, can, cask, barrel,
11 keg, hogshead or other receptacle or container whatsoever, used, corked or
12 capped, sealed and labeled by the manufacturer of alcoholic liquor, to
13 contain and to convey any alcoholic liquor. Original container does not
14 include a sleeve.

15 (v) "Person" means any natural person, corporation, partnership, trust
16 or association.

17 (w) "Powdered alcohol" means alcohol that is prepared in a powdered
18 or crystal form for either direct use or for reconstitution in a nonalcoholic
19 liquid.

20 (x) "Primary American source of supply" means the manufacturer, the
21 owner of alcoholic liquor at the time it becomes a marketable product or
22 the manufacturer's or owner's exclusive agent who, if the alcoholic liquor
23 cannot be secured directly from such manufacturer or owner by American
24 wholesalers, is the source closest to such manufacturer or owner in the
25 channel of commerce from which the product can be secured by American
26 wholesalers.

27 (y) (1) "Retailer" means a person who *is licensed under the Kansas*
28 *liquor control act and* sells at retail, or offers for sale at retail, alcoholic
29 liquors *or cereal malt beverages*.

30 (2) "Retailer" does not include a microbrewery, microdistillery or a
31 farm winery.

32 (z) "Sale" means any transfer, exchange or barter in any manner or by
33 any means whatsoever for a consideration and includes all sales made by
34 any person, whether principal, proprietor, agent, servant or employee.

35 (aa) "Salesperson" means any natural person who:

36 (1) Procures or seeks to procure an order, bargain, contract or
37 agreement for the sale of alcoholic liquor or cereal malt beverage; or

38 (2) is engaged in promoting the sale of alcoholic liquor or cereal malt
39 beverage, or in promoting the business of any person, firm or corporation
40 engaged in the manufacturing and selling of alcoholic liquor or cereal malt
41 beverage, whether the seller resides within the state of Kansas and sells to
42 licensed buyers within the state of Kansas, or whether the seller resides
43 without the state of Kansas and sells to licensed buyers within the state of

1 Kansas.

2 (bb) "Secretary" means the secretary of revenue.

3 (cc) (1) "Sell at retail" and "sale at retail" refer to and mean sales for
4 use or consumption and not for resale in any form and sales to clubs,
5 licensed drinking establishments, licensed caterers or holders of temporary
6 permits.

7 (2) "Sell at retail" and "sale at retail" do not refer to or mean sales by
8 a distributor, a microbrewery, a farm winery, a licensed club, a licensed
9 drinking establishment, a licensed caterer or a holder of a temporary
10 permit.

11 (dd) "To sell" includes to solicit or receive an order for, to keep or
12 expose for sale and to keep with intent to sell.

13 (ee) "Sleeve" means a package of two or more 50-milliliter (3.2-fluid-
14 ounce) containers of spirits.

15 (ff) "Spirits" means any beverage which contains alcohol obtained by
16 distillation, mixed with water or other substance in solution, and includes
17 brandy, rum, whiskey, gin or other spirituous liquors, and such liquors
18 when rectified, blended or otherwise mixed with alcohol or other
19 substances.

20 (gg) "Supplier" means a manufacturer of alcoholic liquor or cereal
21 malt beverage or an agent of such manufacturer, other than a salesperson.

22 (hh) "Temporary permit" has the meaning provided by K.S.A. 41-
23 2601, and amendments thereto.

24 (ii) "Wine" means any alcoholic beverage obtained by the normal
25 alcoholic fermentation of the juice of sound, ripe grapes, fruits, berries or
26 other agricultural products, including such beverages containing added
27 alcohol or spirits or containing sugar added for the purpose of correcting
28 natural deficiencies. The term "wine" shall include hard cider and any
29 other product that is commonly known as a subset of wine.

30 Sec. 5. On and after April 1, 2019, K.S.A. 2016 Supp. 41-307 is
31 hereby amended to read as follows: 41-307. A beer distributor's license
32 shall allow:

33 (a) The wholesale purchase, importation and storage of beer.

34 (b) The sale of beer to:

35 (1) Licensed caterers;

36 (2) beer distributors licensed in this state;

37 (3) retailers, public venues, clubs and drinking establishments,
38 licensed in this state, except that such distributor shall sell a brand of beer
39 only to those retailers, public venues, clubs and drinking establishments of
40 which the licensed premises are located in the geographic territory within
41 which such distributor is authorized to sell such brand, as designated in the
42 notice or notices filed with the director pursuant to K.S.A. 41-410, and
43 amendments thereto; and

- 1 (4) such persons located outside such territory or outside this state as
2 permitted by law.
- 3 (c) The sale of cereal malt beverage to:
- 4 (1) Beer distributors licensed in this state;
- 5 (2) clubs and drinking establishments, licensed in this state, and
6 retailers licensed under K.S.A. 41-2702, and amendments thereto, except
7 that such distributor shall sell a brand of cereal malt beverage only to those
8 such clubs, drinking establishments and retailers of which the licensed
9 premises are located in the geographic territory within which such
10 distributor is authorized to sell such brand, as designated in the notice or
11 notices filed with the director pursuant to K.S.A. 41-410, and amendments
12 thereto; ~~and~~
- 13 (3) *retailers; and*
- 14 (4) such persons located outside such territory or outside this state as
15 permitted by law.
- 16 (d) *The sale of beer containing not more than 6% alcohol by volume*
17 *to cereal malt beverage retailers licensed pursuant to K.S.A. 41-2702, and*
18 *amendments thereto.*
- 19 (e) The purchase of cereal malt beverage in kegs or other bulk
20 containers and the bottling or canning thereof in accordance with law.
- 21 ~~(f)~~ (f) The storage and delivery to a retailer licensed under the Kansas
22 liquor control act or a retailer licensed under K.S.A. 41-2702, and
23 amendments thereto, on the distributor's licensed premises, of alcoholic
24 liquor or cereal malt beverage of another licensed distributor authorized by
25 law to sell such alcoholic liquor or cereal malt beverage to such retailer, in
26 accordance with an agreement entered into with such other distributor and
27 approved by the director.
- 28 ~~(g)~~ (g) The storage and delivery, with proper invoicing in accordance
29 with rules and regulations adopted by the secretary, on the premises of a
30 public venue licensee, of beer sold to or available for purchase by the
31 public venue during an event.
- 32 ~~(h)~~ (h) The withdrawal of beer or cereal malt beverage from such
33 licensee's inventory for use as samples in the course of the business of the
34 distributor or at industry seminars. Samples may only be provided to
35 persons licensed as a distributor or a retailer under the Kansas liquor
36 control act, and such person's employees, or to persons licensed under the
37 club and drinking establishment act, and such person's employees.
38 Samples may be served on the licensed premises of the licensee, or on the
39 premises of a licensed retailer, provided no sample shall be served on that
40 portion of the premises of a licensed retailer that is open to the public and
41 where sales of alcoholic liquor at retail are made. Samples may be served
42 on the premises of a licensee holding a license issued under the club and
43 drinking establishment act, provided no sample shall be served on that

1 portion of the premises that is open to the public and where sales of
2 alcoholic liquor are made. No sample shall be provided to any minor.
3 Nothing in this subsection shall be construed to permit the licensee to sell
4 any alcoholic liquor for consumption on the premises. The withdrawal of
5 beer or cereal malt beverage shall be subject to the tax imposed by K.S.A.
6 79-4101 et seq., and amendments thereto, based on the applicable current
7 posted bottle or case price. For purposes of providing samples pursuant to
8 this subsection other than at industry seminars or to the licensee's
9 employees, the term "sample" shall have the same meaning as that term is
10 defined in K.S.A. 41-2601, and amendments thereto.

11 Sec. 6. On and after April 1, 2019, K.S.A. 2016 Supp. 41-308 is
12 hereby amended to read as follows: 41-308. (a) Except as provided in
13 K.S.A. 2016 Supp. 41-308d, and amendments thereto, a retailer's license
14 shall allow the licensee to sell and offer for sale at retail and deliver in the
15 original package, as therein prescribed, alcoholic liquor *and cereal malt*
16 *beverage* for use or consumption off and away from the premises specified
17 in such license.

18 (b) A retailer's license shall permit sale and delivery of alcoholic
19 liquor *and cereal malt beverage* only on the licensed premises and shall
20 not permit sale of alcoholic liquor *and cereal malt beverage* for resale in
21 any form, except that a licensed retailer may:

22 (1) Sell alcoholic liquor *and cereal malt beverage* to a temporary
23 permit holder for resale by such permit holder; and

24 (2) sell and deliver alcoholic liquor *and cereal malt beverage* to a
25 caterer or to the licensed premises of a public venue, club or drinking
26 establishment, if such premises are in the county where the retailer's
27 premises are located or in an adjacent county, for resale by such public
28 venue, club, establishment or caterer.

29 ~~(b) The holder of a retailer's license shall not sell, offer for sale, give~~
30 ~~away or permit to be sold, offered for sale or given away in or from the~~
31 ~~premises specified in such license any service or thing of value whatsoever~~
32 ~~except alcoholic liquor in the original package, except that a licensed (c)~~
33 *A retailer may:*

34 (1) Charge a delivery fee for delivery *of alcoholic liquor and cereal*
35 *malt beverage* to a public venue, club, drinking establishment or caterer
36 pursuant to subsection ~~(a)~~ (b);

37 (2) sell lottery tickets and shares to the public in accordance with the
38 Kansas lottery act, if the retailer is selected as a lottery retailer;

39 (3) include in the sale of alcoholic liquor *and cereal malt beverage*
40 any goods included by the manufacturer in packaging with the alcoholic
41 liquor *or cereal malt beverage*, subject to the approval of the director; ~~and~~

42 (4) distribute to the public, without charge, consumer advertising
43 specialties bearing advertising matter, subject to rules and regulations of

1 the secretary limiting the form and distribution of such specialties so that
2 they are not conditioned on or an inducement to the purchase of alcoholic
3 liquor; *or cereal malt beverage*;

4 ~~(e) No licensed retailer shall furnish any entertainment in such~~
5 ~~premises or permit any pinball machine or game of skill or chance to be~~
6 ~~located in or on such premises.~~

7 ~~(d) A retailer's license shall allow the licensee to~~ (5) store alcoholic
8 liquor *and cereal malt beverage* in refrigerators, cold storage units, ice
9 boxes or other cooling devices, and the licensee may sell such alcoholic
10 liquor *and cereal malt beverage* to consumers in a chilled condition; *and*

11 (6) *sell any other good or service on the licensed premises, except*
12 *that the gross sales of other goods and services, excluding fees derived*
13 *from the sale of lottery tickets and revenues from sales of cigarettes and*
14 *tobacco products, shall not exceed 20% of the retailer's total gross sales.*

15 Sec. 7. On and after April 1, 2019, K.S.A. 2016 Supp. 41-2701 is
16 hereby amended to read as follows: 41-2701. As used in this act unless the
17 context otherwise requires:

18 (a) "Cereal malt beverage" means any fermented but undistilled
19 liquor brewed or made from malt or from a mixture of malt or malt
20 substitute or any flavored malt beverage, as defined in K.S.A. 2016 Supp.
21 41-2729, and amendments thereto, but does not include any such liquor
22 which is more than 3.2% alcohol by weight.

23 (b) "Director" means the director of alcoholic beverage control of the
24 department of revenue.

25 (c) "Manufacturer" means a manufacturer as defined by K.S.A. 41-
26 102, and amendments thereto.

27 (d) "Person" means any individual, firm, partnership, corporation or
28 association.

29 (e) "Retailer" means any person *who is licensed under the Kansas*
30 *cereal malt beverage act and who sells or offers for sale any cereal malt*
31 *beverage or beer containing not more than 6% alcohol by volume* for use
32 or consumption and not for resale in any form.

33 (f) "Place of business" means any place at which cereal malt
34 beverages *or beer containing not more than 6% alcohol by volume* are
35 sold.

36 (g) "Distributor" means a beer distributor licensed pursuant to the
37 Kansas liquor control act.

38 (h) "Legal age for consumption of cereal malt beverage" means 21
39 years of age, except that "legal age for consumption of cereal malt
40 beverage" shall mean 18 years of age if at any time the provisions of P.L.
41 98-363 penalizing states for permitting persons under 21 years of age to
42 consume cereal malt beverage are repealed or otherwise invalidated or
43 nullified.

1 Sec. 8. On and after April 1, 2019, K.S.A. 2016 Supp. 41-2702 is
2 hereby amended to read as follows: 41-2702. (a) No retailer shall sell any
3 cereal malt beverage *or beer containing not more than 6% alcohol by*
4 *volume* without having first secured a license for each place of business as
5 herein provided. In case such place of business is located within the
6 corporate limits of a city, the application for license shall be made to the
7 governing body of such city. In all other cases, the application for license
8 shall be made to the board of county commissioners in the county in which
9 such place of business is to be located, except that the application for
10 license to sell on railway cars shall be made to the director as hereinafter
11 provided.

12 (b) A board of county commissioners shall not issue or renew a
13 retailer's license without giving the clerk of the township where the place
14 of business is to be located written notice by registered mail of the filing of
15 the application for licensure or renewal. The township board may within
16 10 days file advisory recommendations as to the granting of such license
17 or renewal and such advisory recommendations shall be considered by the
18 board of county commissioners before such license is issued. If an original
19 license is granted and issued, the board of county commissioners shall
20 grant and issue renewals thereof upon application of the license holder, if
21 the license holder is qualified to receive the same and the license has not
22 been revoked as provided by law.

23 (c) An application for a retailer's license shall be verified and upon a
24 form prepared by the attorney general of the state and shall contain:

- 25 (1) The name and residence of the applicant;
26 (2) the length of time that the applicant has resided within the state of
27 Kansas;
28 (3) the particular place of business for which a license is desired;
29 (4) the name of the owner of the premises upon which the place of
30 business is located; and
31 (5) a statement that the applicant is a citizen of the United States and
32 not less than 21 years of age and that the applicant has not within two
33 years immediately preceding the date of making application been
34 convicted of a felony, any crime involving moral turpitude, drunkenness,
35 driving a motor vehicle while under the influence of intoxicating liquor or
36 violation of any other intoxicating liquor law of any state or of the United
37 States.

38 (d) In addition to the fee provided by subsection (e), each application
39 for a retailer's license to sell cereal malt beverages for consumption on the
40 licensed premises shall be accompanied by a fee as follows:

- 41 (1) For licensure of a place of business other than a railway car, a fee
42 of not less than \$25 nor more than \$200, as prescribed by the board of
43 county commissioners or the governing body of the city, as the case may

1 be; and

2 (2) for licensure to sell on railway cars, a fee of \$100.

3 (e) Each applicant for a retailer's license or renewal of such a license
4 shall submit to the director a copy of the completed application for such
5 license or license renewal, together with a fee of \$25. Upon receipt of such
6 application, the director shall authorize a state stamp to be affixed to the
7 license. No such stamp shall be affixed to any license except such stamps
8 as provided by the director and no retailer's license shall be issued or
9 renewed unless such stamp has first been affixed thereto.

10 (f) The director shall remit all fees collected by the director to the
11 state treasurer in accordance with the provisions of K.S.A. 75-4215, and
12 amendments thereto. Upon receipt of each such remittance, the state
13 treasurer shall deposit the entire amount in the state treasury to the credit
14 of the state general fund, except that the director may provide for the
15 deposit in the cereal malt beverage tax refund fund of such amounts as
16 necessary for the refund of any license fees collected hereunder.

17 (g) The board of county commissioners of the several counties or the
18 governing body of a city shall issue a license upon application duly made
19 as otherwise provided for herein, to any retailer engaged in business in
20 such county or city and qualified to receive such license, to sell only cereal
21 malt beverages in original and unopened containers, and not for
22 consumption on the premises. The annual license fee for such license,
23 which shall be in addition to the fee provided by subsection (e), shall be
24 not less than \$25 nor more than \$50.

25 (h) No license issued under this act shall be transferable.

26 Sec. 9. On and after April 1, 2019, K.S.A. 2016 Supp. 41-2704 is
27 hereby amended to read as follows: 41-2704. (a) In addition to and
28 consistent with the requirements of the cereal malt beverage act, the board
29 of county commissioners of any county or the governing body of any city
30 may prescribe hours of closing, standards of conduct and rules and
31 regulations concerning the moral, sanitary and health conditions of places
32 licensed pursuant to this act and may establish zones within which no such
33 place may be located.

34 (b) Within any city where the days of sale at retail of cereal malt
35 beverage in the original package have not been expanded as provided by
36 K.S.A. 2016 Supp. 41-2911, and amendments thereto, or have been so
37 expanded and subsequently restricted as provided by K.S.A. 2016 Supp.
38 41-2911, and amendments thereto, and within any township where the
39 hours and days of sale at retail of cereal malt beverage in the original
40 package have not been expanded as provided by K.S.A. 2016 Supp. 41-
41 2911, and amendments thereto, or have been so expanded and
42 subsequently restricted as provided by K.S.A. 2016 Supp. 41-2911, and
43 amendments thereto, no cereal malt beverages *or beer containing not more*

1 *than 6% alcohol by volume* may be sold:

2 (1) Between the hours of 12 midnight and 6 a.m.; or

3 (2) on Sunday, except in a place of business which is licensed to sell
4 cereal malt beverage for consumption on the premises, which derives not
5 less than 30% of its gross receipts from the sale of food for consumption
6 on the licensed premises and which is located in a county where such sales
7 on Sunday have been authorized by resolution of the board of county
8 commissioners of the county or in a city where such sales on Sunday have
9 been authorized by ordinance of the governing body of the city.

10 (c) Within any city where the days of sale at retail of cereal malt
11 beverage in the original package have been expanded as provided by
12 K.S.A. 2016 Supp. 41-2911, and amendments thereto, and have not been
13 subsequently restricted as provided in K.S.A. 2016 Supp. 41-2911, and
14 amendments thereto, and within any township where the days of sale at
15 retail of cereal malt beverage in the original package have been expanded
16 as provided by K.S.A. 2016 Supp. 41-2911, and amendments thereto, and
17 have not been subsequently restricted as provided by K.S.A. 2016 Supp.
18 41-2911, and amendments thereto, no person shall sell at retail cereal malt
19 beverage:

20 (1) Between the hours of 12 midnight and 6 a.m.;

21 (2) in the original package before 12 noon *or* after 8 p.m. on Sunday;

22 (3) on Easter Sunday; or

23 (4) for consumption on the licensed premises on Sunday, except in a
24 place of business which is licensed to sell cereal malt beverage for
25 consumption on the premises, which derives not less than 30% of its gross
26 receipts from the sale of food for consumption on the licensed premises
27 and which is located in a county where such sales on Sunday have been
28 authorized by resolution of the board of county commissioners of the
29 county or in a city where such sales on Sunday have been authorized by

31 (d) No private rooms or closed booths shall be operated in a place of
32 business, but this provision shall not apply if the licensed premises also are

36 premises licensed as a club pursuant to the club and drinking establishment
37 act shall be open to law enforcement officers and not to the public.

11 (g) No person shall have any alcoholic liquor, *except beer containing*
12 *not more than 6% alcohol by volume*, in such person's possession while in
13 a place of business, unless the premises are currently licensed as a club or
14 drinking establishment pursuant to the club and drinking establishment act.

15 (h) Cereal malt beverages may be sold on premises which are
16 licensed pursuant to both the *Kansas* cereal malt beverage act and the club
17 and drinking establishment act at any time when alcoholic liquor is
18 allowed by law to be served on the premises.
